### 4. FIRST AID MEASURES

#### 4.1 Description of first aid measures:

**In case of respiratory exposure:** Remove to fresh air and keep at rest. If breathing is difficult or has stopped, administer artificial respiration as necessary. Seek medical attention.

**In case of oral intake:** Ingestion is considered unlikely due to product form. However, if swallowed do not induce vomiting. Seek medical attention. Advice to doctor: treat symptomatically.
